Conditions of Membership:

I understand and accept the following conditions of membership and procedure to becoming a full member:

1. Applicants must complete ALL aspects of this Application and Indemnity form.
2. Membership is not automatic or guaranteed.
3. All applications are submitted to the Executive Committee for consideration and acceptance.
4. New applicants must be proposed by two existing PSAWP club members before acceptance.
5. If there is no objection to the new application being accepted, the new member is accepted for a **probationary period** of three months.
6. If there are any objections to a new applicant, the person or persons lodging the objection must give just cause or reason in writing why the applicant should not be accepted as a member.
7. The PSAWP Club Executive Committee will have the final verdict on acceptance or rejection of any application without any further recourse from the applicant.
8. All fees must be paid in advance (application fees, annual membership fees, SASSCo membership fees, SAPSF membership fees & SAGA fees) and is not refundable.
9. I agree to and bind myself to the Constitution of the South African Pin Shooting Association, the Constitution of the Pin Shooting Association of Western Province, the Code of Conduct, the Basic Safety Rules, the Conditions of Membership, and all Range Commands, any or all of which may be changed/amended from time to time.
10. All members / proposed new members / family / heirs / friends absolve and hold harmless the members, Range Officers, and all other representatives of the SAPSF and its affiliates, PSAWP from any claim, loss, harm or damage by whatever means.
11. All members must have a thorough understanding of the Basic Safety Rules and Range Commands and conform to these rules and commands at all times.
12. Once the new member has been provisionally accepted, he/she must undergo an assessment test or **Orientation Course** by the Chief Range Officer or his delegate in order to familiarise himself/herself with all the Range Commands and safety requirements of the sport.
13. If the Chief Range Officer or his delegate decides that the new member:
 - 13.1. is proficient in the safe handling of a firearm;
 - 13.2. knows and understands all Range Commands; and
 - 13.3. is familiar with, understands and adheres to the Basic Safety Rules; then only will a new member under probation be allowed to join the shooting line.
14. If a new member under probation is not proficient in the points as mentioned in point 13 above, the new member will be required to undergo a Beginner's Course. Once the new member has passed the Beginner's Course, the process as outlined in point 13 above will be repeated to the satisfaction of the Chief Range Officer.
15. All new members must complete an assessment and compete under the direction of three separate Range Officers on three separate occasions. These Range Officers will make a recommendation to the Executive Committee to accept the new applicants as full members. The shortest time for any new member under probation to become a full member is three months, in which time he / she must have competed as outlined in this point.
16. No new members will be issued with an **Endorsement Letter** until such time as the member fulfils all requirements of being a dedicated shooter. PSAWP is not obliged by law to issue an Endorsement Letter to any member.
17. **Dedicated Status requirements:**
 - 17.1. Must attend a minimum of 5 shoots per year as per roster and must be in good standing with the PSAWP.
 - 17.2. Minimum period of membership for handguns and manual rifles: 6 months.
 - 17.3. Minimum period of membership for self-loading (semi-auto) rifles, shotguns and self-loading carbines: 12 months.
 - 17.4. Must be a fully paid-up, active member; may not have any outstanding disciplinary pending; may not be serving a suspension.
 - 17.5. Must volunteer periodical help when required.
 - 17.6. Members are obliged to maintain their dedicated status by continued participation as required.
18. Membership extends from the 01 January until the 31 December of each calendar year; and all fees must be paid in advance for the ensuing calendar year.
19. Expulsion from the Club may be exercised at any time in the opinion of the Executive Committee without having to divulge an explanation and without recourse to any claim.

I, the undersigned, hereby declare that all the information supplied above is true and correct.

I hereby bind myself unconditionally to the Constitution of SAPSF, the Constitution of PSAWP. I accept unconditionally all Conditions of Membership, and the Code of Conduct.
